## KENAI PENINSULA BOROUGH ORDINANCE 2018-19-06

## AN ORDINANCE APPROPRIATING \$7,500 FROM THE GENERAL GOVERNMENT CAPITAL PROJECT FUND FOR ADDITIONAL COSTS RELATED TO A REQUIRED CHANGE IN STACK SPECIFICATIONS FOR THE BOROUGH ADMINISTRATIVE BUILDING BOILER

- WHEREAS, the borough administration and Kenai Peninsula School District are located in the George A. Navarre Kenai Peninsula Borough Administration Building ("Building") at 144-148 N. Binkley Street which dates to 1971 with the majority of the heating, ventilation and air conditioning ("HVAC") systems serving the building being at least 30 years old; and
- WHEREAS, the borough assembly approved Ordinance 2017-19-17 appropriating funds for the installation of new higher efficiency boilers to provide a heating source to the Building; and
- WHEREAS, through the formal bidding process the installation bids received were higher than anticipated by \$7,953.89; and
- WHEREAS, the project also experienced an anomaly in the design, resulting from inaccurate information in the products sheets provided by the manufacturer, which caused an additional change order cost impact of \$4,001.20; and
- WHEREAS, with the same intent as the original appropriation, the supplemental costs will be split 50% borough funds, and 50% school project funds;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That funds in the amount of \$7,500 be appropriated from the General Government Capital Project Fund balance account 407.00000.00000.27910 to be transferred to the Maintenance Capital Project Fund account 400.78050.18801.49999 for boiler replacement.
- SECTION 2. This ordinance shall become effective immediately upon enactment.
