The Purchasing and Contracting Office formally solicited and received bids for the ITB19-004, Gravel Road Projects – North, Central & West. Bid packets were released on August 1, 2018 and the Invitation to Bid was advertised in the Peninsula Clarion in the August 1, 2018 issue.

The project consists of placing gravel in the North, Central and West region roads. North Region: 4,000 cubic yards (Nikiski area). Central Region: 3,000 cubic yards (Funny River area). West Region: 3,000 cubic yards (Kasilof area).
