**KENAI PENINSULA BOROUGH
RESOLUTION 2018-038**

**A RESOLUTION APPROVING A MEMORANDUM OF AGREEMENT BETWEEN
THE BOROUGH AND THE MUNICIPALITIES OF HOMER, KACHEMAK, KENAI,
SELDOVIA, SEWARD, AND SOLDOTNA FOR THE PURPOSE OF ESTABLISHING A
MULTI-JURISDICTIONAL TEAM TO REVIEW HAZARD MITIGATION PLANS
AFFECTING THE BOROUGH**

WHEREAS, the Federal Emergency Management Agency ("FEMA") requires local jurisdictions to update the Hazard Mitigation Plan ("HMP") every five years, which enables the borough to apply for FEMA mitigation grants or post-disaster, public assistance funding; and

WHEREAS, FEMA requires documentation that the borough and the municipalities of Homer, Kachemak, Kenai, Seldovia, Seward and Soldotna will work collaboratively to ensure that the municipalities' updated hazard mitigation plans are included as annexes to the borough's HMP; and

WHEREAS, the Memorandum of Agreement ("MOA") between the borough and the local municipalities reflects the desire to work together, aligning the five-year update process as well as reviewing shared HMP products, elements or mitigation actions as an effort to reduce costs, eliminate duplication or identified redundancy; and

WHEREAS, the municipalities of Homer, Kachemak, Kenai, Seldovia, Seward and Soldotna have signed the MOA; and

WHEREAS, the assembly finds it is in the best interest of the borough to participate in the multi-jurisdictional team;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. The Memorandum of Agreement between the Kenai Peninsula Borough and Municipalities of Homer, Kachemak, Kenai, Seldovia, Seward, and Soldotna for the Purpose of Establishing a Multi-Jurisdictional Team to Review Hazard Mitigation Plans Affecting the Borough is approved.


SECTION 2. The mayor is authorized to sign the Memorandum of Agreement as presented a copy of which is attached hereto and incorporated by reference.


SECTION 3. This resolution shall become effective immediately upon adoption.
