**KENAI PENINSULA BOROUGH
ORDINANCE 2018-19-14**

**AN ORDINANCE APPROVING THE PURCHASE OF A DA VINCI SURGICAL
ROBOTIC SYSTEM PLUS ON-SITE IMPLEMENTATION AND TRAINING FOR THE
CENTRAL PENINSULA HOSPITAL AND APPROPRIATING \$2,250,000 FROM THE
PLANT REPLACEMENT AND EXPANSION FUND TO FUND THE PROJECT**

- WHEREAS,** the Kenai Peninsula Borough has entered into an Operating Agreement with Central Peninsula General Hospital Inc. (“CPGH, Inc.”) for the operation of Central Peninsula Hospital and other medical facilities, and to provide other healthcare programs and services, on a nonprofit basis to ensure continued availability to the service area residents; and
- WHEREAS,** improved surgical capability is necessary to meet the needs of residents of the Kenai Peninsula as well as supporting a comprehensive surgical program; and
- WHEREAS,** the FY19 Capital Budget for CPGH, Inc. provides information for the purchase of a da Vinci surgical robotic system for \$2,500,000 which will improve the hospital’s surgical capabilities, better meeting the community’s needs; and
- WHEREAS,** the hospital has negotiated the purchase of a da Vinci surgical robotic system for \$2,015,000 plus on-site implementation costs of \$235,000 for a total cost of \$2,250,000, which meets CPGH, Inc.’s needs to provide this service at the hospital; and
- WHEREAS,** sufficient funds are available in the Central Peninsula Hospital Plant Replacement and Expansion Fund (“PREF”) to fund this purchase; and
- WHEREAS,** under Section 16(b) of the Operating Agreement, transfers in or out of the CPH, Inc. PREF shall first be considered by the CPGH, Inc. board and its recommendation forwarded to the assembly; and
- WHEREAS,** during its meeting of September 27, 2018, the CPGH Inc. Board of Directors approved the purchase of a da Vinci surgical robotic system, including on-site implementation and training, for a total amount of \$2,250,000;


NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the assembly approves the purchase of a da Vinci surgical robotic system, including on-site implementation and training, for a total cost of \$2,250,000, with the funds for payment to be made from the CPH, Inc. PREF.


SECTION 2. That \$2,250,000 is appropriated from the CPH, Inc. PREF to account no. 490.81110.19DAV.49999 for the purchase of a da Vinci surgical robotic system, including on-site implementation and training.

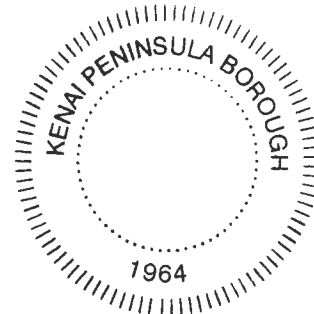
SECTION 3. That this ordinance shall become effective upon its enactment.
