**KENAI PENINSULA BOROUGH  
ORDINANCE 2018-19-20**

**AN ORDINANCE ACCEPTING AND APPROPRIATING ADDITIONAL FUNDS IN  
THE AMOUNT OF \$8,850 FROM THE STATE OF ALASKA DEPARTMENT OF  
MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND  
EMERGENCY MANAGEMENT FISCAL YEAR 2017 STATE HOMELAND SECURITY  
PROGRAM GRANT**

**WHEREAS,** the State of Alaska Department of Military and Veterans Affairs, Division of Homeland Security & Emergency Management ("DHS&EM") provides funds to enhance the capability of local governments to prevent, deter, respond to and recover from all-hazard incidents and to enhance regional preparedness efforts; and

**WHEREAS,** the DHS&EM State Homeland Security Program ("SHSP") is a federal grant pass through program with the Federal Emergency Management Agency which provides funding for planning, equipment, training and exercises; and

**WHEREAS,** Ordinance 2017-19-09 approved the fiscal year 2017 SHSP grant award on behalf of the Soldotna Public Safety Communication Center ("SPSCC") to upgrade the computer-aided dispatch system for the fire station alerting project; and

**WHEREAS,** the borough applied for and received additional funding of \$8,850 under the fiscal year 2017 SHSP grant program to upgrade the virtual message switch used for law enforcement platforms within the computer aided dispatch system; and

**WHEREAS,** it is in the best interest of the borough to accept the grant funds;


**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept \$8,850 from the State of Alaska Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management and to execute a grant agreement and any other documents deemed necessary to accept and to expend the grant funds and to fulfill the intents and purposes of this ordinance.

**SECTION 2.** That grant funds in the amount of \$8,850 are appropriated to account number 271.94910.18HSP.49999.

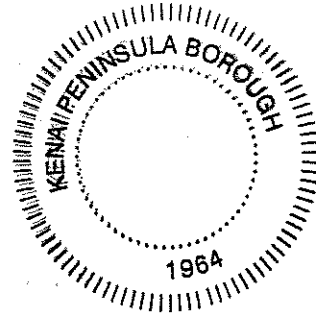
**SECTION 3.** This ordinance shall become effective immediately upon its enactment.
