**A RESOLUTION NAMING THE KENAI PENINSULA BOROUGH ASSEMBLY
CHAMBERS THE BETTY J. GLICK ASSEMBLY CHAMBERS**

- WHEREAS,** in 1981 Betty was recognized in the “Who’s Who of American Women” for her dedication to her community and to Alaska; and,
- WHEREAS,** Betty J. Glick served on the Kenai City Council and as Vice Mayor of the City of Kenai; and
- WHEREAS,** Ms. Glick served on the Kenai Peninsula Borough Planning Commission and as its Chair; and
- WHEREAS,** Ms. Glick served on the Kenai Peninsula Borough Assembly from 1982 through 1995 and then again from 2002 through 2005; and,
- WHEREAS,** Betty served as Assembly Vice President and as Assembly President multiple times during her tenure; and
- WHEREAS,** Ms. Glick served on the executive board of the Alaska Municipal League and as its President from 1983-1984; and
- WHEREAS,** Ms. Glick was the first female President of the Western Interstate Region Board of Directors in 1990, representing 16 Western Public Lands States; and
- WHEREAS,** Ms. Glick served as the Alaska Representative to the National Association of Counties Board of Directors; and
- WHEREAS,** Ms. Glick serves on the Kenai Peninsula Borough’s Board of Equalization and served on its Board of Adjustment; and
- WHEREAS,** Betty served on the Kenai Peninsula Borough’s Election Canvass Board as well as acting as the Election Board Chair for the Kenai No. 2 Precinct for several years; and
- WHEREAS,** Ms. Glick served as co-chair on the Kenai Peninsula Borough’s Reapportionment Committee in 2001 and as chair in 2011; and

WHEREAS, Ms. Glick has selflessly served the constituents of the Kenai Peninsula Borough since her arrival to Alaska in 1961;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 2. That a copy of this resolution shall be sent to Betty J. Glick.

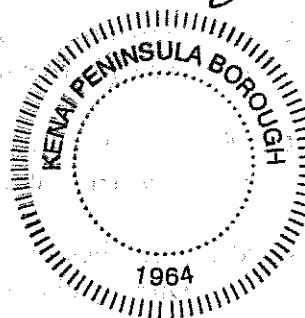
SECTION 3. That this resolution takes effect immediately upon its adoption.
