


# **FY20** Highlights

- Formalized Auto Aid Agreements with Ninilchik Emergency Services and Homer Volunteer Fire Departments.
- Support for Forestry on North Fork Fire
- Mobile Data Terminals iPads with CAD in 10 vehicles.
- Provided Firefighter I and EMT I Classes.
- Hosted National Fire Academy Class. Another class postponed due to COVID-19
- Provided over 3000 man-hours of training to members.
- Additional certifications of three (3) Fire Service Instructor I's
- Replacement of boiler at Station 1





### 61% increase in calls for service since 2010












- Volunteer recruitment and retention
- 55% reduction in volunteer response since 2011








# **FY21** Initiatives

- Complete in-ground water tank capital project at north end of the service area
- Rental shop to house Ladder 1 and other equipment.
- Volunteer shifts at Station to provide more efficient coverage
- Obtain funding to replace self-contained breathing apparatus.
- Reduce our community risk through continued training.
- Continued training on ladder truck operations.
- Host additional National Fire Academy Classes in Anchor Point









- 36' x 60' SHOP AT 72470 CLUTTS AVE DIRECTLY NORTH OF ANCHOR POINT FIRE STATION
- 24'W x 16'H HYDRAULIC SWING DOOR, 2<sup>ND</sup> BAY WITH 12'W X 16'H ROLLUP DOOR
- PLUMBED WITH COMPRESSED AIR, EXTERIOR LED LIGHTING, AND SECURITY CAMERAS
- NATURAL GAS HEAT, PUBLIC WATER, 200 AMP ELECTRIC SERVICE
- \$2000 / MONTH RENT AND ESTIMATED \$400 MONTH UTILITIES VS \$410K CONSTRUCTION /





### **FY21 Budget Detail Changes**

- 40120 Temporary Wages increased \$30,000 to support volunteer shifts
- **43019 Software Licensing** increase includes \$1,500 for CrewForce (CAD) annual maintenance and \$3,500 for Target Solutions (Training Management Software)
- 43110 Communications increased \$9,000 for iPad data services for CAD
- 43610 Utilities increased \$4,800 for additional building
- 43720 Equipment Maintenance includes \$4,585 for shared cost of OEM radio program manager position





### **FY21 Budget Detail Changes**

- 43810 Rents and Operating Leases Increased \$24,000 for additional building
- 48710 Minor Office Equipment Increase of \$5,817 includes replacement of outdated Bizhub 2000 copier/printer/scanner, replacement of network switch at Station 1, and purchase of iPads for remaining apparatus.
- **48755 Minor Recreation Equipment** \$6,500 for replacement of worn out exercise equipment at Station 1
- 43260 Training can be reduced by \$2,000
- **43210 Transport/Subsistence** can be reduced by \$4,765 due to cancelation of the Alaska State Fire Conference
