Testimony of Elaina Spraker

Good Evening, President Cooper and Assembly members, for the record, my name is Elaina Spraker, I am the Clinic Director for a NRA authorized fire arm training program called Women on Target and Teens on Target. Brenda Ahlberg, is our Co-Director of the program. We have trained over 800 women and adolescents. I am here testifying today in support of 2020-29.

Ivan Moore Poll April 2018

- Residents of the Kenai Peninsula, showed significantly more conservative attitudes toward gun regulation than in the rest of the state.
- Thirty percent of respondents reported living in a household with NRA membership in the Kenai, versus 18 percent in the rest of the state. Two thirds of the Kenai population oppose an assault weapons ban, with approximately 31 percent in support, as opposed to 48 percent of respondents supporting the measure in the rest of the state.
- Kenai residents also differ on proposals to ban high-capacity magazines — only 32 percent support the idea, while 49 percent of the rest of the state support the idea.
- The study reported the percentage of people who would support allowing teachers to carry guns on campus as significantly higher in the Kenai than elsewhere in the state. Sixty percent of Kenai residents support the idea, compared to 44 percent in the rest of the state. Overall, 45 percent of Alaskans support the idea of arming teachers.
- Homer Friends of the NRA is one of the top fund raising committees in the nation. As was Kenai for many years.

A new wave of the 2A protection moving across our nation that works to pass ordinances across cities and towns that say local authorities won't comply with state and federal gun restrictions they believe infringe their Second Amendment rights. Alaska was one of the first to adopt passage of this type of statewide measure. This type of ordinance rejects enforcement of state or federal gun laws perceived to violate the Second Amendment. Never say never, targeted regulations commonly include red flag laws, universal gun background checks, and bans on assault-style weapons, currently there are places in the United States where 2A rights are being eroded continually. Take for example Virginia.

To purchase a firearm in the state, gun owners have to pay a \$5 application and provide fingerprints, consent to a mental health records check, and two references.

Plus! You have to wait 30 days for local law enforcement to process the forms, but gun owners say it can take months.

In the span of two months, more than 120 towns, cities, and counties in Virginia have declared themselves "Second Amendment sanctuaries" where "unconstitutional" gun laws would not be enforced.

As our borough assembly, you need to decide if you're going to represent your constituency. You can argue whether or not it's enforceable, however, I believe that is irrelevant to supporting another layer of 2A protection.

Your actions comes from the people's power -the Kenai Peninsula is the set aside when it comes to protection of 2nd Amendment rights. I hope you will support you community.
