I am writing to request a NO vote on finance committee decision to fund the Dominion Voting system purchase agreement. Also known as 2020-19-24, this agreement has many flaws. The fact that Dominion software updates "from time to time" as stated in Sec 3.1 of the agreement and that it uses 3rd party software as stated in sec 3.8 should give you pause. Also disturbing is Sec 6.4 that grants Dominions "access and entry into borough property", with no specific limits defined. Sections 8.2 and 10.2 go on to describe how Dominion will use its "best efforts" to ensure the software works, not exactly reassuring to me. If you are still not concerned, sections 12.1 and 12.2 describe how confidential information between the borough and Dominion will be on a "need to know basis" unless it is COURT ODERED! The final and significant concern of this contract is Sec 13 where limits of liability for Dominion are the cost of the contract for any breach, negligence, liability or any other duty.

To vote yes to this contract I believe you put the finances of the borough at risk of significant monetary damage from litigation. You may also want to review with the borough attorney whether each individual member of the assembly may be joined in the potential lawsuit.

I oppose installation of a voting system that has been found to have modem connectivity to the cloud or internet. Dominion has been proven to have such hardware and software capabilities. Kenai Peninsula Votes (KPV) supports Ordinance 2020-19-24, the purchase and leasing of the Dominion voting machines. The Borough and the Election Stakeholder's Group have done their research and compared different systems and Dominion was the choice. If the Assembly votes down this ordinance, it will be a waste of tax payer's money and time to try and come up with a new system.

Dominion machines were chosen because they meet the ADA compliance issues that were brought forth from a lawsuit regarding accessibility issues when voting. I would think that delaying the purchase of these machines would be in violation of the timeline to meet the requirements of the lawsuit.

The machines leave a paper trail and are secure. In our last election our State did a check on the reliability of the machines as we recounted Ballot Measure 2. Here is a quote from the Midnight Sun: "The state completed its unusual audit of the vote on Ballot Measure 2, a move that Lt. Gov. I ask that KPB Assembly give some thought before moving forward with potentially securing Dominion as our voting machine vendor and request that you do not vote to do so for the following reasons:

- 1. Dominion voting machines are subject to at least 6 lawsuits as a result of the November 2020 election. These lawsuits are still in litigation, and their outcomes are unknown currently. Why buy equipment from a vendor whose product is subject to such litigation, potentially hampering the Borough's ability to conduct elections in the future?
- 2. The State of Texas considered and then refused to purchase any Dominion machines in 2019.
  - Perhaps the Assembly should postpone the proposed 2020-19-24 until it determines why Texas refused to buy Dominion machines.
- 3. Florida primarily uses the ES&S election system. They counted 11 million votes by midnight of the General election on November 3rd, 2020, and have not had any lawsuits filed. How did Florida count 11 million votes and release all the results on election day without ANY accusations or lawsuits filed? In fact, ES&S, itself, is not embroiled in any lawsuits.

Any upgrades to Borough voting machines should use paper ballots and not function with any network or wireless access or capability. Any ADA concerns should be addressed in a manner to protect the integrity of the vote, while accommodating the voter's particular need.

Additionally, our Kenai Peninsula Clerk's office currently does not have a Standard Operating Procedure for managing our elections. Before the KPB purchases ANY voting tabulation machines, the Assembly should produce a SOP detailing 1.) how our current elections are managed, and 2.) how the machines are distributed, including a tracking system containing all the serial numbers of our current

machines. The public has a right to know how our current elections are managed; a written Standard Operating Procedure should exist and be available for public scrutiny.

I am requesting that the Kenai Peninsula Borough NOT purchase Dominion Voting system equipment. <u>2020-19-24</u>. The reason for this request is that I claim Dominion Voting Systems have a seriously questionable business history and future.

Historically Dominion representatives have assured customers that their voting systems themselves are not designed to be online, but in a great many cases they end up online anyway and thereby put the voting process itself at risk. It is a tremendous risk for any election systems to be connected online, even momentarily because that connection presents a serious hacker risk opportunity. Once a hacker begins talking to the voting system through a modem, they can change unofficial election results, they can hack the software in the voting machine and make it cheat the election. Direct hard-line internet connections present a serious hacker risk and wireless network connections present an even greater risk. The National Institute of Standards and Technology, which provides cybersecurity frameworks for state and local governments and other organizations, recommends that voting systems should not have internet network connections. We cannot just ignore the fact that in the past Dominion voting systems ended up with connection modems when Dominion Representative's claimed they did not have them.

I see KPB election equipment evaluation being driven by minority issues like a human rights visual complaint from the Alaska State Commission for Human Rights (ASCHR). How does an issue that ends up affecting maybe 1% of our population generate more concern than an issue that affects 100% of our population?

Voter visual disability is not more important than voting system security. Complying with the Americans with Disabilities Act (ADA) and the Help America Vote Act of 2020 (HAVA), may appear to be a lofty goal but what good are those complying votes if they are deleted by an international hack? Our KPB election systems have serious internet connection risks that are being ignored while visual rights are absorbing the boroughs attention. This is like spending all your time and resources creating a fancy frosting for a rotten cake. The borough may need new ADA compliant voter equipment but how does that get more attention than election system & software security?

The KPB Dominion Voting system purchase agreement known as <u>2020-19-24</u>, is so full of bottomless holes that they are difficult to even address. Sec. 6.4 gives Dominion the legal authority to walk onto kpb

property at anytime and do whatever they want to these systems. Since I do not trust Dominion I find this to be another unnecessary security threat. At the very least Dominion should be required to request kpb property access. Sec. 12.2 allows confidential information between the kpb and Dominion to be on a "need to know basis" unless it is court ordered! What is that? This basically means the kpb may be required to beg Dominion for information about its own voting equipment! It is unrealistic and illogical to force the kpb to beg its own equipment supplier for maintenance information. Then there is the huge matter of the Sec. 13 disclaimer that limits Dominion's liability for all its possible negligence or any breaches that may occur. When a company needs this kind of a monstrous disclaimer they in fact need it for a big reason. That reason is the billions of dollars worth of law suits which have been filed against them and their equipment.

Have you notice the multiple billions of dollars worth of law suits that have been filed against and by Dominion? It is very likely that Dominion Voting Systems will not even be around in the very near future because of these mounting litigations that are stacking up against and by them. What happens if all these liabilities go the wrong direction leaving the kpb with millions of dollars worth of equipment without a supplier to help maintain it? Then the kpb would be forced to just dump all these Dominion systems and that will cost the borough millions of dollars in future voter system replacements. Has the the kpb considered the likelihood of Dominion being around in the future with billions of dollars in litigations hanging over its head? Why would the kpb seek out a voting system supplier that has these kind of liabilities?

The fact that Dominion software updates "from time to time" as stated in Sec 3.1 of the agreement and that it uses 3rd party software as stated in sec 3.8 should give you pause. Also disturbing is Sec 6.4 that grants Dominions "access and entry into borough property", with no specific limits defined. Sections 8.2 and 10.2 go on to describe how Dominion will use its "best efforts" to ensure the software works; not exactly reassuring to me. If you are still not concerned, sections 12.1 and 12.2 describe how confidential information between the Borough and Dominion will be on a "need to know basis" unless it is COURT ORDERED! The final and significant concern of this contract is Sec 13 where limits of liability for Dominion are the cost of the contract for any breach, negligence, liability or any other duty.

I believe by voting yes to this contract you would put the finances of the Borough at risk of significant monetary damage from litigation. You may also want to review with the Borough attorney whether each individual member of the assembly may be joined in the potential lawsuit.

I oppose installation of a voting system that has been found to have modem connectivity to the cloud or internet. Dominion has been proven to have such hardware and software capabilities. Please do not argue that the Borough has no intention of using that feature. As stated in the memorandum, the desire of proceeding with a new system is to use "intergovernmental administration" and collaboration with other cities. If you are not convinced that Dominion voting systems have internet capability and therefore vulnerability, please look up this link from NBC news.


It's come to my attention that the borough may be interested in purchasing new voting machines. I cannot express enough how crucial a fair and transparent voting system is to the survival of our democracy.





I ask that KPB Assembly give some thought before moving forward with potentially securing Dominion as our voting machine vendor and request that you do not vote to do so for the following reasons:

- 1. Dominion voting machines are subject to at least 6 lawsuits as a result of the November 2020 election. These lawsuits are still in litigation, and their outcomes are unknown currently. Why buy equipment from a vendor whose product is subject to such litigation, potentially hampering the Borough's ability to conduct elections in the future?
- 2. The State of Texas considered and then refused to purchase any Dominion machines in 2019.
  - Perhaps the Assembly should postpone the proposed 2020-19-24 until it determines why Texas refused to buy Dominion machines.
- 3. Florida primarily uses the ES&S election system. They counted 11 million votes by midnight of the General election on November 3rd, 2020, and have not had any lawsuits filed. How did Florida count 11 million votes and release all the results on election day without ANY accusations or lawsuits filed? In fact, ES&S, itself, is not embroiled in any lawsuits.

Any upgrades to Borough voting machines should use paper ballots and not function with any network or wireless access or capability. Any ADA concerns should be addressed in a manner to protect the integrity of the vote, while accommodating the voter's particular need.
