2021-18 An Ordinance Amending Title 4 Regarding Borough Elections and Enacting a New Chapter of Code, KPB 4.60, Election Security and Integrity, to Ensure Borough Elections are Accessible, Reliable and Secure (Bjorkman, Elam)

Bjorkman moved to enact Ordinance 2021-18

President Hibbert called for public comment.

There being no one else who wished to speak the public comment period was closed. Bjorkman moved to amend Ordinance 2021-18 as follows:

Section 2, 4.60.030 Ballot Tabulator tests and security. to read, "A. The automatic tabulating equipment used for counting ballots (tabulator) at voting places shall be tested publicly [THREE]two times for each election: before the election, [IMMEDIATELY] and before the counting of ballots.[,] [AND IMMEDIATELY] <u>A[a]</u>fter the counting of ballots <u>a post-election audit shall be</u> <u>performed.</u>

D. Upon completion of the automatic count, [THE TABULATOR SHALL AGAIN BE TESTED] <u>a post-election audit shall be performed</u>, and if the [INITIAL TEST IS] <u>audit confirms the automatic count and does not present any discrepancies</u> [SUCCESSFUL] the automatic count is valid for the purpose of certifying the election returns. [OTHERWISE, THE AUTOMATIC BALLOT COUNT IS VOID.] <u>If</u> <u>discrepancies are identified a recount shall take place for that precinct prior to</u> <u>certification.</u>"

4.60.080 Poll watcher Section 2 to read,

"A. Each candidate <u>and interested parties</u> may appoint a poll watcher for each voting place. For the purposes of this subsection, the term "interested parties" shall mean any <u>initiative or referendum sponsors and parties that timely submitted statements</u> <u>supporting or opposing initiative or referendum.</u>"
