The modeled values are statistically tested to ensure a level of accuracy and equity of assessment that meets the guidelines established by the Alaska Association of Assessing Officers and the International Association of Assessing Officers, and are in compliance with State Statutes.  The Assessing Department did a physical on-site inspection to ensure all land influences were applied correctly and has made a reduction as a result.
