KENAI PENINSULA BOROUGH ORDINANCE 2021-19-16

AN ORDINANCE APPROPRIATING ESTIMATED INSURANCE PROCEEDS OF \$847,000 FOR THE COST OF THE NANWALEK TEACHER HOUSING REPLACEMENT PROJECT

- WHEREAS, a teacher housing building in Nanwalek, owned by the Kenai Peninsula Borough (KPB) and operated by the Kenai Peninsula Borough School District ("KPBSD"), was destroyed by a structure fire in 2020 with the remaining structure being demolished and the site cleared the same year; and
- **WHEREAS,** plans were completed to rebuild the structure and went out for public competitive bidding in July of 2021, only one bid in the amount of \$847,000 was received to complete the project; and
- **WHEREAS**, with the loss of the structure, KPBSD is in need of teacher housing in Nanwalek as soon as possible; and
- **WHEREAS,** the total project cost is estimated to be \$959,510.64, including demo, design, reconstruction, project management and other related project costs; and
- WHEREAS, the borough's deductible for the claim is \$100,000; and
- **WHEREAS**, the borough insurer has approved the request for insurance coverage for the reconstruction portion of the project; and
- **WHEREAS,** an appropriation of \$847,000.00 is needed to award a contract for the construction of the teacher housing in Nanwalek which will be reimbursed by the insurance company; and
- WHEREAS, the remaining \$112,510.64 in project costs are to be paid from the borough's Insurance and Litigation Fund;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to receive property insurance proceeds from the borough's insurers for the Nanwalek teacher housing reconstruction project.

- **SECTION 2.** That the mayor is authorized to issue an award and enter into a contract for reconstruction of the Nanwalek teacher housing
- **SECTION 3.** That estimated insurance proceeds in the amount \$847,000 are appropriated to account 400.71030.J008Y.49999 for the purpose of funding the reconstruction portion of the project.
- **SECTION 4.** That the appropriations made in this ordinance are of a project length nature and as such do not lapse at the end of any particular fiscal year.
- **SECTION 5.** That this ordinance is effective immediately upon enactment.
