ASSEMBLY COMMENTS

Assembly Member Bagley welcomed everyone to 2016.

Assembly Member Welles wished everyone a happy new year.

Assembly Member Dunne thanked Dr. Merrick for his presentation and to Mayor Navarre for including it with his report. Mr. Dunne said it was a very important conversation and a true public health issue. He apologized for not attending in person and appreciated the ability to attend by phone.

Assembly Member Ogle wished everyone a happy new year. He stated there were a lot of interesting things happening this year, such as the presidential election, the state budget crisis and our local elections. Mr. Ogle reminded everyone of the AK LNG community meeting on January 7, 2016, 6:00 p.m. at the new Senior Center in Nikiski and also that the borough was sponsoring a AK LNG meeting on January 21, 2016, 6:00 p.m. at the Nikiski Recreation Center. He congratulated Marge Ware on celebrating her 98th birthday. He stated that Wes and Marge Ware were one of the original homesteaders around. Mr. Ogle congratulated the Nikiski Boys Basketball team, who traveled to Kona for a tournament over the holidays and achieved a 5-1 record.

Assembly Member Cooper congratulated the Homer Mariners wrestling team on their state championship and stated they have a great athletic department and coach. She thanked Dr. Merrick for his presentation and thanked Mayor Navarre for inviting him. Ms. Cooper stated she was thankful that Central Peninsula Hospital was providing transitional housing. She stated that action told her that we have a community hospital that was very much interested in what was best for the community. She stated if the stigma was eliminated and embrace treatment in the community, our health care costs would go down.

Assembly Member Johnson stated he appreciated the audit presentation and was thankful that the borough's financial situation was stable. He complemented Craig Chapman, Finance Director; Brandi Harbaugh, Controller; Mayor Navarre and the Assembly Members for controlling our spending over the years. He stated the revenue sharing the borough received from the state was going to be missed but was thankful we were financially in good shape.

Assembly President Gilman thanked Dr. Merrick for his presentation and stated he would like the hospital to come forward with costs of a detox facility. He stated that addiction should not be viewed as a criminal model but a medical issue and we need

to shift away from that approach to help reduce incarceration costs.
