Amend KPB 5.18.430(A) in Section 2 to read; "The sales tax referred to in KPB 5.18.100 shall be applied only to the first \$1,000.00[500.00] of each separate sale, rent or service transaction, except as otherwise provided in this section. [ON JANUARY 1 OF EVERY FIFTH YEAR, BEGINNING JANUARY 1, 2022, THIS MAXIMUM TAXABLE AMOUNT SHALL BE ADJUSTED BASED ON CHANGE IN INFLATION AS CALCULATED IN THE YEAR IMMEDIATELY PRECEDING THE EFFECTIVE DATE OF THE ADJUSTMENT AND BASED ON THE **PRECEDING** FIVE YEARS AS **MEASURED** BYALASKA **DEPARTMENT** OF LABOR **ANCHORAGE CONSUMER PRICE** INDEX, **DOWN ROUNDED** TO THE NEAREST \$10, **SUBJECT** TO **ASSEMBLY AMENDING** THIS **SECTION** TO THE APPROVAL REFLECT **ADJUSTED** AMOUNT. FOR PURPOSES OF CALCULATING THE FIVE-YEAR INFLATION ADJUSTMENT TO THE MAXIMUM TAXABLE AMOUNT, THE BOROUGH FINANCE DIRECTOR SHALL CALCULATE THE ADJUSTMENT BASED ON THE PERCENTAGE CHANGE IN INFLATION FOR THE FIVE-YEAR PERIOD USED IN THE CALCULATION.]

..."; and

Amend KPB 5.18.430(F) in Section 2 to read; "[EXCEPT FOR INFLATION ADJUSTMENTS TO THE MAXIMUM TAXABLE AMOUNT], A[a]ny increase to the maximum sales tax described in subsection (A), above, shall not take effect until ratified by a simple majority of voters at a regular borough election."; and

Amend Section 3 to read as follows; "That a ballot proposition shall be placed before borough voters at the next regular election to read as follows:

PROPOSITION No.	

Shall the provisions in Section 2 of Ordinance 2016-16, increasing the maximum amount of a sale subject to the borough sales tax from \$500 to \$1,000 [WITH AN ADJUSTMENT FOR INFLATION EVERY FIVE YEARS] be ratified?

YES ____ A "yes" vote means that the maximum amount of a sale subject to the borough sales tax will be increased \$1,000 [AND THEN ADJUSTED FOR

INFLACTION EVERY FIVE YEARS]. If the mayority vote "yes", a secondary result or byproduct of that vote would be that monthly rental amounts for residential dwelling units used as a premanent place of abode will be exempt from borough sales tax.

NO ____ A "no" vote means that the maximum amount of a sale subject to the borough seales tax will remain at a maximum of \$500. If the marjoirty vote "no," a secondary result or byproduct of that vote would be that borough sales tax will continue to be charged on rental amounts for residential dwelling units used as a permanent place of abode."

Amend the title to read, "AN ORDINANCE <u>ACCEPTING A TRANSFER OF LIMITED RECREATIONAL POWERS FROM THE CITY OF HOMER AND AUTHORIZING A NEGOTIATED LEASE AT LESS THAN FAIR MARKET VALUE WITH SAH SOCCER, INC. dba SOCCER ASSOCIATION OF HOMER OF APPROXIMATELY 3.5 ACRES OF BOROUGH LAND ADJACENT TO THE HOMER MIDDLE SCHOOL FOR THE DEVELOPMENT, MANAGEMENT AND MAINTENANCE OF A YEAR-ROUND INDOOR FIELD AKA "SOUTH PENINSULA ATHLETIC AND RECREATION CENTER"; and</u>

Amend the second Whereas clause to read, "WHEREAS, the City of Homer commissioned the 2015 Parks, Art, Recreation and Culture (PARC) Needs Assessment which identified as the most significant priority space needs for year-round indoor recreational activities, including those within the scope of the SPARC indoor field; and" and

Add the following four new Whereas clauses before the last three Whereas clauses to read, "WHEREAS, the Kenai Peninsula Borough comprehensive plan Goal 4.10 Objective 1 is to encourage coordination between the borough and cities which provide recreational facilities; and

WHEREAS, the City of Homer has recreational powers and the Kenai Peninsula Borough does not have recreational powers within the City of Homer; and

WHEREAS, AS 29.25.010(7) and AS 29.35.310 provides that a city may transfer a power to a second class borough by ordinance; and

WHEREAS, the indoor recreational facility would be located within the South Kenai Peninsula Hospital Service Area which has wellness program powers; and"; and

Amend the second to last Whereas clause to read; "WHEREAS, the Kenai Peninsula Borough Board of Education at its regularly scheduled meeting of June 6, 2016 recommended the lease to SAH Soccer, Inc. for the development of an indoor soccer facility; and" and;

Amend Section 1 by adding the following finding; "The City of Homer has recreational powers and a vision for indoor recreational facilities while the borough does not have recreational powers within the city limits of Homer but has a land management division that routinely manages leases for a variety of functions."

Amend Paragraph 3.A of the findings of facts in Section 3 to read; ". The use of the subject land for indoor field purposes will benefit the public <u>health and</u> welfare <u>by providing indoor recreational facilities</u> and is consistent with prior field uses."; and

Add a new Section 8 to read; "That the Assembly hereby accepts from the City of Homer a transfer of limited recreational powers for the sole purpose of entering the lease which is the subject of this ordinance for the management, development, and maintenance of an indoor recreational facility. The borough shall exercise all powers and functions necessarily or fairly implied in or incident to the lease of the subject land for the management, development, and maintenance of an indoor recreational facility."; and

ASSEMBLY COMMENTS

Assembly Member Bagley congratulated Taylor Ostrander for being a candidate for the NCA Woman of the Year award.

Assembly Member Holmdahl stated the assembly had heard a lot of public testimony regarding cutting the budget and raising taxes, however, there was a point where cuts were no longer feasible in order to serve the people and provide a certain level of services. She stated that the borough staff and Mayor did a great job with this year's budget.

Assembly Member Knopp stated he agreed with Ms. Holmdahl's comments. He stated he was concerned about several proposals the Governor was considering and how it would impact the borough, which made it difficult for the borough to respond accordingly. He stated the ballot questions regarding code revisions to the sales tax and senior exemptions were appropriate. Mr. Knopp stated he was looking closer at the property and sales tax questions and thought a work session with the assembly was needed. He stated the Mayor did not cut or layoff positions, instead he found effeciencies in combining departments and positions, which he felt was appropriate.

Assembly Member Dunne thanked the Tsalteshi Trails and Cook Inlet Keeper sponsors of the "Mouth to Mouth" race on June 18, 2016 which was a foot and bicycle race from the mouth of the Kasilof River to the mouth of the Kenai River. Mr. Dunne also thanked everyone at the South Peninsula Athletic and Recreation Center and the Soccer Assocation for their collaboration with the City of Homer and the Borough on the lease agreement that was approved. He stated he was concerned that most of the testimony given regarding the invocation issue was an "us vs. them" mentality and stated we should all work together on the matter.

Assembly Member Ogle stated he was opposed to Proposition 2 and marijuana. He stated he was impressed with Ms. Phelps' pledge and work within the marijuana organizations had been conducted in a very professional manner. He stated while he doesn't approve of their industry, he respected their integrity. Mr. Ogle stated fracking was a well known oil extraction process and thought it was great that the Mayor was finding more information for the public. He thanked the Mayor's office for the Western Federal Lands efforts and appreciated their work. Mr. Ogle stated he voted in favor of the sales tax cap question on the ballot and was looking forward to the town hall meetings. He stated he supported Mr. Knopp's idea of a work session to review the proposed sales and property tax revisions.

Assembly Member Cooper appreciated everyone's testimony and stated they could agree to disagree in a respectful manner. She stated the best example of that was the nine members of the assembly.

Assembly Member Johnson appreciated hearing Ms. Holmdahl's comments. He stated that Mike Dimmick ran the radio equipment in the back of assembly chambers and that his wife served on both the planning commission and assembly for years and she was a past president. Mr. Johnson stated it was good to see him.
